They Call It the Green Line, After All Council 5 is a sponsor of Opening Day celebrations on

Saturday June 14 for Green Line light-rail service in Minneapolis and St. Paul.

The Green Line provides a new transportation option for 15,000 AFSCME members who work along the Central Corridor: in state agencies, in Hennepin and Ramsey Counties, in the cities of Minneapolis and St. Paul, at the University of Minnesota's East and West Bank campuses, and at hospitals such as Regions, Hennepin County Medical Center, and University of Minnesota Medical Center-Fairview.

Riders will see AFSCME advertising in each Green Line train car. Trains begin running at 10 a.m. June 14; celebrations last from 9 a.m.-4 p.m. that day. They include music, food, and theater at nine stations.

- Six telemetry technicians and 22 community health workers at Hennepin County Medical Center are the newest members of AFSCME. Workers in the two classifications joined Local 2474 through an accretion agreement when a majority of them signed cards seeking representation through AFSCME.
- Also, 15 workers at the Minneapolis Parks and Recreation Board have joined Local 9 after a clarification ruling added them to the bargaining unit.

Per Capita Tax Meetings Continue

Informational meetings are scheduled through June 23 on the Council 5 Executive Board's proposal to increase the council's monthly per capita tax by \$5 a month beginning in 2015. The per capita is the council's share of total dues.

"FIVE FOR THE FIGHT" would be the first boost in the per capita since Council 5 formed 10 years ago. Convention delegates will vote on the board's recommendation Sept. 12.

Locals Ratify Contracts

Housing and Redevelopment Authority of Duluth.

Members in this unit of Local 66 ratified a three-year contract through 2016. It includes raises of 1 percent retroactive to Jan. 1, and 2 percent in January 2015 and January 2016. It also creates afternoon and night differentials; enables part-time workers to progress through pay steps; and increases clothing allowances.

Proctor School District. Bus drivers in this unit of Local 66 ratified a two-year contract through June 30, 2015. The agreement includes a 2 percent pay raise retroactive to July 1, 2013, and a 2.25 percent pay raise on July 1, 2014; creates a 403(b) retirement account for veteran drivers; and reimburses drivers up to \$125 for physical exams required by the state.

Ramsey County Care Center. Members of Locals 8, 151, and 1076 ratified a salary supplement, based on funds appropriated by the state Legislature. The supplement boosts pay by 18 cents an hour, effective June 1.

Learning from Our Past

Former Local 1164 president Joe Burns will give a free talk on June 21 about his latest book, "Strike Back: Using the Militant Tactics of Labor's Past to Reignite Public Sector Unionism Today."

Burns points out that hundreds of thousands of public workers rose up in the 1960s and 1970s to demand collective-bargaining rights. He suggests that today's public workers – who are fighting unprecedented attacks on their jobs – can learn from past tactics.
