Unit 8 Contract Vote Nov. 30 – Dec. 4

Delegates for Unit 8 (corrections) voted this morning to bring a tentative contract agreement and mediator's proposal to the full membership for a vote. After 8 hours of mediation, the union and employer couldn't reach agreement, so the mediator offered a proposal. The compromise would give union members five additional shift exchanges, up to a maximum of 33 exchanges a year. That gain was ranked as a top priority for delegates going into negotiations. The compromise would give the employer one shift of an employee's accumulated vacation balance in lieu of the employee serving an unpaid suspension. The employer's goal was to save money with this change in discipline.

The tentative contract agreement negotiated by Unit 8 includes a pay raise of 2.5 percent retroactive to July 1, 2015; another 2.5 percent raise on July 1, 2016; plus steps in both years. That means employees still eligible for annual steps could see their pay increase by 10 percent by the time the two-year contract expires. The annual pay raises would more than offset modest increases in health-insurance costs.

Unions on campus have been in contract negotiations since late June. The U of MN has yet to propose an acceptable wage increase. Their current offer is between 0.25 and 0.75 percent. Dec. 24: State Employees Get Backpay

State Contracts Approved

The Legislature's Subcommittee on Employee Relations met on Oct. 29 to consider approval of contracts that cover 15,600 AFSCME members who work for the Executive Branch in Unit 2 (craft and maintenance), Unit 3 (service), Unit 4 (health care), Unit 6 (clerical), Unit 7 (technical) and Unit 25 (radio communications). The end result was a tie vote along party lines. You can listen to an audio recording of the two-hour committee hearing at the SER website: www.ser.leg.mn/audio.

The tie vote means the SER took no action, so the contracts will go to the Legislature for final approval during the 2016 session. School Board candidate Renee VanNett came in just short of winning her race.

We swept the City Council races in Maplewood, helping to elect Tou Xiong and Bryan Smith.

St. Paul City Council President Russ Stark and Members Dai Thao, Chris Tolbert, Dan Bostrum and Jane Prince were elected. Our Ward 2 candidate Darren Tobolt was narrowly defeated. All of our candidates for St. Paul School Board – Zuki Ellis, Steve Marchese, Jon Shumacher, and Mary Vanderwert – won their races.

In the District 46A special election, our endorsed candidate Peggy Flanagan was successfully elected.

No Federal Shutdown

President Obama signed a spending package on Nov. 3 that will fund the federal government through Sept. 30, 2017. The deal also raises the debt limit until March 2017. This means all federally funded programs and services supported by the State of Minnesota will continue. No state employees will be laid off due to a federal shutdown.
