



## AFSCME Turns Capitol Green at Day on the Hill

About 1,200 Council 5 members packed the state Capitol Tuesday, working to protect our future.

Workers from across the state came out in force to push for a state budget that will secure a brighter future for hardworking Minnesotans, our families and our communities.

They met directly with their state representatives and senators. Members asked lawmakers to defend our pensions, reinvest in the work we do, staff up for safe workplaces, move forward on transportation, ban private prisons, protect children, make education affordable and support local control.

Members filled the Rotunda for a thunderous rally, sending chants of "Who does the work? We do!" reverberating through the dome.

## AFSCME Fights Private Prison Lease

Correctional officers are moving the fight against privately owned prisons to the state Senate, after a House committee rejected a private prison ban. DFL legislators supported the ban, while GOP members opposed it.

Correctional officers testified at a House committee hearing March 21 that they don't want our state doing business with an infamous corporation like CoreCivic (aka CCA). The Corrections Commissioner has repeatedly told legislators the department doesn't want or need the CCA-owned

Appleton prison, and the Governor keeps vowing to veto it. <http://afscmemn.org/fightprivateprisons>.

## Protesting HCMC Layoffs

Members rallied March 17 against nearly 200 layoffs at Hennepin County Medical Center and how those layoffs were handled.

Workers say they treat every patient with kindness, dignity and respect, and they deserve the same treatment from their employer.

Council 5 says management is discriminating against older workers, people of color, women, veterans and union leaders. AFSCME is suing HCMC and the Hennepin County Board of Commissioners for violating the contract, and seeking an order to temporarily block the layoffs and give workers their jobs back with no loss of pay or seniority.

## Minneapolis Mayoral Candidate Endorsed

Council 5 has endorsed Ward 3 City Council member Jacob Frey for Minneapolis mayor.

“We believe Jacob Frey has the energy and vision to guide Minneapolis into being a safe and vibrant place for both the workers and residents of our great city,” says Local 9 president Sarah Maxwell.

Four candidates spoke at a March 11 AFSCME PEOPLE forum: Frey, Mayor Betsy Hodges, state Rep. Raymond Dehn and Tom Hoch. Candidates Aswar Rahman and Nekima Levy-Pounds were invited but didn’t attend.

AFSCME has endorsed several City Council candidates: Jillia Pessenda (Ward 1), Cam Gordon (Ward 2), Barb Johnson (Ward 4), Blong Yang (Ward 5), Lisa Goodman (Ward 7), Andrea Jenkins (Ward 8) and Linea Palmisano (Ward 13). Screenings for the remaining wards are coming.
