PEOPLE Power Delivers Victory

- Two constitutional amendments: Defeated.
- The Republican majority in the Minnesota Senate: Gone.
- The Republican majority in House: Gone.
- AFSCME members were fed up with legislative extremists who spent two years targeting our livelihoods, our services, our union, and our rights instead of fixing the state's problems.
- So we turned around and targeted 15 legislators who showed an utter lack of respect for public workers and retirees. *We defeated all 15 of them.*
- AFSCME members, staff, and retirees were tireless. We knocked on thousands of doors and made hundreds of thousands of phone calls to get out the vote. On the weekend before the election, 300 AFSCME volunteers hit the streets and phones statewide. That was as many activists as all other unions combined.
- It was all part of a bigger effort to win a middle-class majority in the Legislature and beat back the avalanche of cash from secretive corporate donors.

- The sale takes place Sunday Dec. 2, from 10 a.m.-6 p.m., at the CWA Local 7200 hall, 3521 E. Lake St., Minneapolis. Clothes, crafts and other items will be from Minnesota's own Union House and Ten Thousand Villages.
- The event, which includes entertainment and refreshments, benefits the Fair Trade Coalition, which promotes trade policies supporting social, workplace, and environmental justice.

Don't Forget: Boycott Crystal Sugar

- With holiday baking season coming on fast, don't forget to boycott Crystal Sugar. In addition to its name brand, the sugar-beet co-op also produces private-label and "house" brands for many major grocery chains, including Target.
- The best way to avoid buying any Crystal Sugar product is to buy cane sugar instead (such as C&H or Domino).
- The nationwide boycott continues until the company ends its 15-month lockout of 1,300 workers in Minnesota, North Dakota, and Iowa.

SEPC Seeks State Contract Proposals

Dec. 3 is the deadline to submit contract and inequity proposals for the next round of state negotiations on the 2013-2015 collective bargaining agreement. All proposals must come directly from a Local and be signed by the Local president.

Download forms: To submit a contract or inequity proposal, fill in the forms from Council 5's website: www.afscmemn.org; click "Bargaining Updates," then click "State of Minnesota Bargaining 2013-2015."

SEPC delegates: Dec. 14 is the deadline for locals to submit updated lists of delegates and alternates to the State Employee Policy Committee. These lists take effect at the Feb. 4 Negotiations Assembly meeting in Bloomington.

College Scholarships Available

AFSCME is accepting scholarship applications for members to attend the National Labor College, and for children of members attending college.

National Labor College: The application deadline is Nov. 15 for these scholarships, which are worth \$2,000-\$10,000 a year for working members pursuing a bachelor's degree online. Details and downloads are available through the link at www.afscme.org/members/scholarships.

AFSCME Family Scholarship: Provides \$2,000 college scholarships for up to four years for full-time students. Students must be graduating high-school seniors who have a parent, legal guardian, or financially responsible grandparent who is a full, dues-paying AFSCME member.

Jerry Clark Memorial Scholarship: Provides a \$5,000 scholarship per year, plus an internship, for college juniors and seniors majoring in a social science who are the children, legal dependent, or financially dependent grandchildren of AFSCME members.
