Generosity by the Ladle

Local 66 members at Western Lake Superior Sanitary District raised \$683 this year at their annual chili feed. The lunchtime fundraiser, held Dec. 13, pays tribute to the union's 2002 strike, when kettles of chili sustained strikers and solidarity through the December cold. In addition, the workers have a clause in their contract in which proceeds from lunchroom vending machines also go toward the fundraiser. Combined, it means the workers are donating more than \$940 to AFL-CIO Community Services in Duluth, and to Union Gospel Mission, where members have served a monthly meal for 10 years.

Generosity by the Armful

For the tenth straight year, members of St. Cloud State University Local 753 adopted a local family in need for the holiday season. The family – a working mother with three children – received toys, household needs, clothing, monetary gifts, and a decorated tree. Local 753 members also volunteered to ring bells for the Salvation Army's Red Kettle campaign, and made fleece blankets for the Warm Blanket Project, which stockpiles blankets for emergency personnel to use with adults and children in crisis.

MnSCU Local 4001 is celebrating the life of Dr. Martin Luther King Jr. by sponsoring a march and observance on Jan. 19. Events kick off with a community march at 4 p.m. that Saturday. The march goes from KMOJ Radio, 2123 W. Broadway Ave., Minneapolis, to the Urban League, 2100 N. Plymouth Ave. There, a program begins at 5 p.m. It features praise dance, artists, and speakers (including Gary Armstead, of Hennepin County Human Services Local 34).

New Year Brings New Contracts

City of Apple Valley: Members of Local 479 ratified a one-year contract for 2013. It includes pay raises of 35 cents an hour on Jan. 1, plus 2 percent more on April 1. Also, because of work backlogs caused by short-staffing, the city also agrees to schedule \$93,000 of overtime in 2013.

The contract adds a floating holiday, creates guidelines and bonus pay of up to four hours for on-call duty, and increases the city's health insurance contribution. Those contributions increase by \$10 a month for a co-pay plan, and \$40 a month for a high-deductible plan.

Town of Rice Lake: Members of this Local 66 unit ratified a two-year contract through 2014. It includes pay raises of 2 percent each year, with no changes in health insurance.

City of Savage: Members of Local 3378 ratified a two-year contract through 2014. It includes pay raises of 2 percent in January 2013 and in January 2014; counts all comp time as regular hours for accrual and other purposes; and allows employees to cash out vacation twice a year. It also eliminates the annual clothing allowance of \$300 a year, but adds 25 cents an hour to base pay, which is worth \$520 a year for full-time workers.

The world premiere of a play about Minnesota union and civil rights activist Nellie Stone Johnson takes place Jan. 26-Feb. 17 at the History Theatre in St. Paul.

"Nellie," written by Kim Hines, tells of the race and gender barriers that Johnson broke in fighting for equality at work, on campus, and in the political arena. Delegates to Council 5's 2012 Convention saw staged readings of scenes from the play.
