Right now, Dakota County is making important budget decisions that will directly affect the services our communities depend on and the workers who provide them.

This is about protecting essential public services

Every day, county employees serve veterans, seniors, children, people with disabilities, families, and residents across Dakota County. These services cannot simply disappear when funding is reduced.

At the same time, state and federal governments continue to require counties to provide more services and meet higher standards without providing the funding to pay for them.

Those unfunded and underfunded mandates leave counties with difficult choices: reduce services or find local funding to continue meeting community needs.

Support Scenario #2

As you talk with neighbors, friends, family members and elected officials, remember these three talking points:

- **Protect Essential Services.** Veterans, seniors, children, families, and people with disabilities depend on county services every day. **Supporting Scenario #2** (25% levy) helps ensure these essential services remain available when people need them.
- **Protect Our Workforce.** County workers keep Dakota County running. When positions are eliminated, the work doesn't disappear. It is shifted to fewer employees, creating delays, larger workloads, and reduced services for residents.
- **Protect Our Communities Future.** State and federal governments continue shifting costs to counties. Supporting **Scenario #2** is an investment in safe, healthy, and thriving communities. Strong public services make Dakota County a better place to live, work, and raise a family.
